Foreword by the Director General

In 2018, the WIPO Academy will celebrate its 20th anniversary as the global center of excellence for intellectual property (IP) training, education and human capacity building. It will continue to provide courses covering the full range of IP topics in several languages and formats and to increase access globally to high-quality IP education and training. The WIPO Academy's 2018 Education and Training Programs Portfolio demonstrates the Organization's continuing commitment to this strategic goal, in particular in terms of providing access for participants from least developed and developing countries and countries with economies in transition. The courses offered in 2018 further build on the WIPO Academy's extensive experience in this field and fully harness the international network of partnerships which it has carefully nurtured with national, regional and international institutions.

In 2018, the WIPO Academy's courses will continue to use distance learning (DL) to increase access to IP knowledge. In 2017, there was an increase of 20 percent in the overall number of participants in our DL courses. This demand is also increasing for specialized DL courses and for tailored versions of standard courses in terms of both language and content. Partnerships are another way in which the Academy is both generating and managing demand. In 2017, the WIPO Academy signed a Cooperation Agreement with the National Institute of Industrial Property of Brazil (INPI) to strengthen cooperation on the administration of DL courses, similar to the Cooperation Agreement signed with the China Intellectual Property Training Center (CIPTC) the previous year. Cost is another factor which affects access. Fee reductions that were introduced in 2016 for distance learning courses will be maintained.

A further focus in 2018 is the need to ensure that the Academy responds effectively to the training needs of Member States. The courses offered by the Professional Development Program (PDP) in 2018 are increasingly delivered in synergy with the technical assistance provided by other Divisions within WIPO. The PDP courses are designed and offered in full partnership with our Member States. The courses will also continue to enhance South-South cooperation, maximising the IP knowledge and skills that exist in the South through new partnerships. Rigorous evaluation and assessment of these courses are

also important and will allow the Academy to review the presentation and learning objectives of its long-standing training courses. The information gathered will be used to ensure that PDP courses most effectively meet the needs of Member States.

The WIPO Academy will continue to promote and support access to IP higher education in 2018 through its Academic Institutions Program (AIP). Two new Joint Master's Programs will be launched: one with the University of San Andres, Argentina, and another with the Jagiellonian University, Krakow, Poland. The Academy will also allocate resources to support universities in other ways, further increasing access to IP higher education. The WIPO Summer School Program continues to grow in popularity and in 2018 the majority of these schools will be provided in partnership with universities as well as IP offices to help ensure the best mix of target participants. Finally, the AIP will continue to support countries – upon request – to localize training by helping them to build training capacity through the establishment of national IP Training Academies in WIPO Member States and “Train the Trainer” projects.

The Judicial Training Institutions Project in Costa Rica, Lebanon, Nepal and Nigeria is due to be completed in 2018. A number of Member States have already requested to be involved in a possible follow-up phase of the project.

Preface

2018 marks the 20th anniversary of the WIPO Academy. It also offers an opportunity to assess the work done and to reflect on the strategic and innovative orientations needed to maintain its position as the global center for intellectual property training and education. Improving its course offerings, reaching new target beneficiaries and reducing fees for participation will continue to be among its priorities in the years ahead. This is critical for the Academy to ensure that it achieves its primary goal of providing access globally to IP knowledge and building human capacity in the field of IP, particularly in least developed and developing countries and countries with economies in transition. As demand continues to grow in terms of both volume and the need for greater specialization and customization of its courses, the WIPO Academy's Portfolio of Courses must continue to deliver its core training courses while at the same time adapting to meet these new and diverse demands.

The WIPO Academy's 2018 Education and Training Programs Portfolio of Courses once again offers a wide range of courses covering all areas of intellectual property, provided in a variety of formats and languages. These range from basic and advanced distance learning courses, to professional development training for government officials, and to higher education and the teaching of Joint Master's degree courses on IP at the postgraduate university level. All of these courses are delivered in close cooperation with partner institutions and with external, independent academic expertise. The strong reputation that the Academy has built since its foundation in 1998 rests to a great extent on the quality of the education it is providing, its credibility as a neutral and impartial source of knowledge, and the extensive network of highly respected partners that it works with.

To summarize the main highlights and new developments that the Academy will offer in 2018:

- 23 training courses for government officials and other stakeholders from the public sector on a variety of IP areas will be organized during the year. As in the past, these will be organized in close cooperation and full partnership with Member States, IP offices and IP institutions. In 2018, additional emphasis will be given to enhance South-South cooperation by further developing strategic partnerships with developing

countries to contribute their IP knowledge and skills for the benefit of fellow developing countries. These professional development courses will focus on practical training, technical knowledge and case studies. The courses cover regularly requested themes, including patent information and documentation, trademark procedures, collective management of copyright and related rights, technology transfer and innovation, and management and administration of IP offices.

- A record 28 courses will be offered through the Distance Learning (DL) Program. The DL Program will add new courses and new language versions of existing courses to complement its existing offerings and to respond to the demand for more specialized IP education in areas such as: Advanced International Certificate Course on IP Asset Management (Based on IP Panorama and DL-450-IP Management Courses); IP-Impact Certificate Course (IPCC); Intellectual Property for Teachers of the Young; Enforcement of Intellectual Property Rights (DL-303) and Introduction to WIPO's Industrial Property Automation System for Administrators (DL-IPAS). A dedicated state-of-the-art IT platform and a network of some 200 tutors all over the world are mobilized for the delivery of these DL courses in the six UN languages and in Portuguese. The General Course on Intellectual Property (DL-101) which was piloted in 2016 in an accessible format for the blind, visually impaired, or otherwise print disabled will continue to be offered in 2018.
- Two new Joint Master's Degree Programs will be offered in 2018: A joint Master's Degree in Intellectual Property and Innovation with *Universidad de San Andres* and the National Institute of Industrial Property (INPI), Buenos Aires, Argentina, and a Master Degree Program in IP and New Technologies (MIP and New Technologies) with Jagiellonian University, Krakow, Poland. These programs reflect a growing demand for specialization in IP higher education and will complement the existing Joint Master's programs offered by the Academy with a number of top universities across the globe. A limited number of scholarships are available for qualified graduates from developing countries, LDCs and countries with economies in transition to participate in these postgraduate programs.

- In addition to this year's WIPO-WTO Colloquium for IP Teachers in Geneva, the WIPO Academy and the WTO will organize its second regional Colloquium for IP Teachers and Researchers, which will be hosted by the University of South Africa, Pretoria, South Africa and will take place from April 9 to 13, 2018.
- There will be a total of 16 WIPO Summer Schools organized in 2018 in cooperation with partners at venues across the globe, responding to the continuing popularity and demand for places at these schools.
- In 2018, the Academy will finalize the implementation of the Judicial Training Institutions Project in the four pilot countries, namely, Costa Rica, Lebanon, Nepal and Nigeria. The Academy will also start offering similar assistance to other countries.

This Portfolio serves as a catalogue of all the training opportunities to be offered by the WIPO Academy in 2018 and outlines the content of each course. It gives information to potential participants on eligibility criteria, application formalities, timelines, selection procedures, travel and other relevant necessary information.

Professional Development Program

Professional Development Program

General information

The Professional Development Program of the WIPO Academy offers some 23 training courses a year for participants from developing countries including least-developed countries (LDCs) and from countries with economies in transition. The courses are organized with a number of partner institutions, including national IP offices.

The training courses to be held in 2018 are described in the following pages. For each course, information is given about its objectives, rationale, program highlights, language of training, target audience, distance learning course prerequisites, venue, duration and possible dates. For certain courses, exact dates are not available at time of writing so please check the WIPO Academy website, www.wipo.int/academy, for up-to-date information.

The following paragraphs provide information on application procedures, travel, accommodation, medical coverage, visa requirements and related matters which apply to selected candidates.

1. Prerequisites

Candidates for the training courses offered under the Professional Development Program (PDP) should have completed or be prepared to complete the Distance-Learning Course as designated in the description of each training course.

Candidates are required to have a working knowledge of the language in which the training course will be conducted.

2. Application procedure

Candidates for the training courses offered under the Professional Development Program are required to register online at: <https://welc.wipo.int>. Only applications submitted online will be considered. Under each training course, the dates and the deadlines for registration are provided. A candidate can register for a maximum of two courses.

For government officials, registration needs to be endorsed by the Director General of the office or a senior official of the relevant ministry before it can be considered. It is also necessary to attach the relevant required documents as described on the Professional Development

Program page of the WIPO Academy website. Follow the step-by-step instructions described under "How to register". For any assistance, please email us at: pdp@wipo.int

3. Selection of candidates

The selection of candidates is carried out by WIPO. The selected candidates are notified by email first, with a formal invitation letter sent thereafter. Only selected candidates are notified. Information on travel and other administrative arrangements will be also notified directly to selected candidates.

Selected candidates will be required to complete the relevant Distance-Learning course prior to their participation (if not yet completed prior to their selection).

4. Medical insurance

Participants in courses of two weeks or more are covered by medical insurance taken out by WIPO for the training period. Details of the medical insurance scheme are sent to selected candidates.

5. Medical examination

Candidates selected for a training course lasting two weeks or more are required to undergo a medical examination confirming that they are in good health. The medical examination is to be carried out by a physician recognized by the United Nations in the candidate's country. When applicable, WIPO informs the selected candidates of the requirement for medical examination through the relevant UNDP office.

6. Visa requirements

As regards entry visa requirements (where applicable) of countries in which the training courses are organized, WIPO will not authorize the selected candidates to participate in the course unless they have obtained all the required entry visas in advance.

7. Travel and accommodation

Travel and subsistence expenses are borne by WIPO and/or by the governments or organizations cooperating with WIPO in offering the training course. Participants receive a daily subsistence allowance adequate to cover the cost of meals and accommodation, where applicable.

8. Evaluation

Selected candidates are required to fill out a pre-training evaluation questionnaire which is prepared by WIPO for

each course. The responses to the questionnaire, which are shared with the speakers, enable us and the speakers to know beforehand expectations of the participants and if necessary to adjust the program accordingly.

At the end of each course, participants are required to complete an online evaluation questionnaire prepared by WIPO or by the partner institution. The answers to the questionnaire are treated in strict confidence. They serve as a basis to assess the various courses and to improve them in the future. There will also be follow-up surveys (e.g. six months after the course, etc.) for feedback to WIPO on how the participants are applying the information learned during the courses. This helps determine the utility and impact of the courses.

9. Attendance

Regular attendance is mandatory throughout the training period. WIPO reserves the right to terminate the fellowship of any participant who fails to meet this requirement.

10. Accompanying persons

Participants are requested not to bring any accompanying persons to courses. WIPO will not take any responsibility or incur administrative costs or take any action (e.g., make travel arrangements, provide a subsistence allowance, arrange entry visas or insurance, etc.) for such persons. Arrangements made for the participants by WIPO and/or the host institutions are solely for the benefit of the participants.

11. Award

A certificate of participation is awarded to each of the participants at the end of each training program.

Distance Learning Program

General information

1. Objectives

By harnessing technology to facilitate the delivery of academic programs remotely, the WIPO Academy Distance Learning Program aims to increase the accessibility of IP knowledge on a global scale, making it available to all, irrespective of geographic location, socio-economic background, industry sector or language group.

2. Background

In 1998, the WIPO Academy adopted distance learning as an innovative teaching approach, investing in the potential of the Internet to expand its educational mandate. Since its launch, approximately 550,000 people from all over the world have taken one or more WIPO distance learning courses.

3. Field and scope of training

The WIPO Academy has placed considerable emphasis on incorporating teaching methodologies and pedagogies that complement the e-learning process: the Bloom Method is a learning technique rooted in cognitive behavioral psychology in which people learn by “remembering, understanding, applying, analyzing, evaluating and creating”. The instructional design of the course content is based on the Open University of the United Kingdom: “you teach, you ask, you assess and you evaluate” the learner’s ability to apply and perform tasks at different intervals. The combined use of these two systems facilitates the effective transfer of information and knowledge between teachers and learners in the virtual environment.

The WIPO Academy networks with other institutions involved in teaching about intellectual property through distance learning in order to combine substantive knowledge and pedagogical expertise in the design and development of courses. Partnerships with universities around the world enable the WIPO Academy to identify core groups of experts to serve as authors providing and enhancing the content of the courses with regional and national teaching materials.

The WIPO Academy is the only institution which offers online courses in IP in seven languages with a suite of learner support. A unique feature of WIPO’s Distance Learning Program is the focus on language diversity and online academic and administration support. The Primer (DL-001), the General Course on IP (DL-101) and most of the advanced courses are now available in

the six official languages of the United Nations (Arabic, Chinese, English, French, Russian and Spanish) as well as Portuguese, with further translations into other languages underway.

The WIPO Academy distance learning courses cover all aspects of IP. Learners and teachers can interact as often as necessary during the courses because communication takes place through online discussion forums and electronic mail. Teachers have their own interaction tools which allow them to correct exams and support any difficulties that learners may face during the course.

The courses offered via distance learning include self-paced general courses, tutor-led advanced courses and courses that combine both online education and face-to-face training (i.e. blended learning).

4. Teaching

All of the above-mentioned specialized and advanced level courses are supported by in-house tutors and some 200 external expert practitioners in the field of IP.

5. Course syllabus

Each of the courses is divided into modules which are preceded by a list of learning outcomes. These learning outcomes provide the details of the competencies that participants should aim to achieve upon completion of the relevant module. Self-assessment tools are strategically placed within each module to help learners gauge their levels of knowledge and progress and their ability to apply concepts and facts encountered throughout the course.

6. Dynamic teaching on current IP issues and learner needs

The Program is adapted to the dynamic needs of learners and includes cases, landmark decisions and treaties made in the relevant field.

7. Target audience

The WIPO Academy's distance learning courses are available to a variety of end users, from professionals in the field to creators and those with a general interest in IP. In addition to employees of IP offices, groups such as lawyers, patent agents, engineers, artists, performers, economists, journalists, business owners and university students can benefit from the Academy's tailor-made courses, which address general and specific IP issues.

As demand increases for more knowledge in specific areas of IP policy-making, the Academy is responding with three new DL courses: the Executive Course on IP and Access to Medical Technologies (DL-701), Copyright Collective Management for Policy Makers (DL-506) and Software Licensing Including Open Source. Furthermore, in line with WIPO's commitments on accessibility, the Academy will officially introduce Accessible Intellectual Property Training (AIPT) courses within our DL program, for individuals who are blind, visually impaired, or otherwise print disabled. The General Course on Intellectual Property (DL-101) is now available in an accessible format in all UN languages (Arabic, Chinese, English, French, Russian and Spanish) as well as Portuguese.

Following increased demand for IP knowledge from our Chinese target audience, and to facilitate the corresponding high-volume access to the DL courses, a Cooperation Agreement was signed in 2016 between the Academy and the China Intellectual Property Training Center (CIPTC) of the State Intellectual Property Office of China (SIPO). Starting in 2017, the Chinese version of the DL courses will be offered from within China, with the same standards as the Academy's DL courses in the five UN languages and Portuguese.

8. Registration

The registration process is facilitated by the Academy Registration and Payment Interface (ARPI), an electronic system that enables prospective students to enroll in courses and monitor the status of their applications.

9. Evaluation

The student evaluation process for the DL program is designed to test students' abilities to apply facts and concepts taught throughout the course. It includes a single final exam (which may be written essay or multiple-choice format) that is administered to the participants via the WIPO Academy learning management platform.

Students are permitted to complete the final exam across a range of timeframes that vary from five hours to five days, prior to uploading their answers via the learning management system for grading by their assigned tutors.

10. Tuition and fees

1. Primer on Intellectual Property (DL-001)

Description	<p>This “primer” course aims to provide participants with knowledge of the fundamental aspects of intellectual property (IP): copyright and related rights, trademarks, patents, geographical indications and industrial designs. It also introduces contemporary issues impacting the IP field such as new plant varieties, unfair competition, enforcement of IP rights and emerging issues in IP.</p> <p>Self-evaluation tools are strategically incorporated throughout each of the 12 modules to help each participant gauge their level of knowledge and test their ability to apply concepts and key facts taught during the course.</p>

2. General Course on Intellectual Property (DL-101)

It provides participants with a more in-depth overview of the fundamentals of intellectual property (IP) law, and is indispensable for the more advanced courses of study on specific areas of IP law. Self-assessment tools are strategically placed throughout each module to help each participants gauge their level of knowledge and progress and their ability to apply the concepts and facts presented within the course.

It is designed for self-directed learning, with each participant working through the course material at their own pace. Self-assessment tools are strategically placed throughout each module to help each participant gauge their levels of knowledge and progress and their ability to apply the concepts and facts presented within the course.

4. IP Panorama (DL-IP PANORAMA)

IP PANORAMA teaches IP from a business perspective, focusing especially on the situation of SMEs. It is based on the instructional design strategy of storytelling supported by educational technology. The learning content of each module is designed around a practical story regarding IP.

Teaching	Academic support is provided throughout each module by experienced tutors who are expert practitioners in the field of IP.
Online discussions and assignments	Using the Academy's enhanced learning platform, experienced tutors/IP experts discuss landmark cases with participants. 9. Advanced Course on Intellectual Property, Traditional Knowledge and Traditional Cultural Expressions (DL-203)

It covers key concepts and international, regional and national experiences, policy options and legal mechanisms that are already available or under consideration to provide such protection. It aims to strengthen capacity and stimulate consideration of these issues, share experiences and advance understanding of the range of issues and possible options in this area, in which legal and policy developments are still evolving at national, regional and international levels.

As the course covers the relationship between IP, TK and traditional cultural expressions, participants who are already familiar with the IP system may be best placed to benefit from it. Prospective participants who are not already familiar with the IP system are recommended to take course DL-001 Primer on Intellectual Property or course DL-101 General Course on Intellectual Property, both of which are available free of charge, before studying this course.

18. Advanced Course on Collective Management of Copyright and Related Rights for Legal Practitioners (DL-501)

Description	<p>This advanced course aims to build participants' knowledge about the fundamentals of copyright and in particular the international copyright treaties that have bearing on management and enforcement of rights nationally. It provides an overview of issues in which legal practitioners are customarily involved in relation to the collective management of copyright and related rights, and also outlines how creators, users, legislators and society at large benefit from the system of collective management. Legal practitioners need to understand what CMOs do, how they acquire mandates from rights holders and how they license the use of protected works. Although practitioners' advice may be required on almost any aspect of collective management, the most common issues concern the establishment of a collective management organization, the agreements that are concluded with rights holders and users of protected works, as well as the settlement of tariff disputes and aspects of competition law.</p>
Content and structure	<p>The course includes 13 modules and a final exam. The first module is a general introductory module on the collective management of copyright and related rights, which is then followed by a module on collective management of copyright and related rights for legal practitioners and the modules from course DL-201 Advanced Course on Copyright and Related Rights. 19. Advanced Course on Collective Management of Copyright and Related Rights for Rights Holders (DL-502)

Description	This advanced course is targeted at anyone intending to learn in depth about collective management, but especially primary rights holders, and aims to raise awareness of how creators, users, legislators and society at large benefit from the system of collective management. It covers the workings of collective management of copyright in the categories of music, text and images, works of visual art and photography, and dramatic works. After a basic introduction to copyright and related rights, refreshing knowledge that participants should already have before studying the course, it identifies the three main elements of a well-functioning copyright system: legislation, policy and management of rights. The overriding principle is that whenever it is impracticable or impossible for intellectual property (IP) rights holders to exercise their rights individually, collective management is a feasible solution. The course examines the synergies that exist among stakeholders in the legal, creativity, management, and policy arenas in order to balance the benefits to creators and society. It also discusses the day-to-day work of CMOs and how they are governed. Finally, learners can examine the challenges and opportunities brought about by digital technologies and the Internet through pre-planned questions and answers as well as dynamic discussions among peers and experts.

20. Advanced Course on Collective Management of Copyright and Related Rights for Collective Management Organizations (CMOs) (DL-503)

Description	This advanced course is targeted at anyone intending to learn in depth about collective management, especially people from collective management organizations (CMOs). It aims to raise awareness of how creators, users, legislators and society at large benefit from the system of collective management. It covers the workings of collective management of copyright in the categories of music, text and images, works of visual art and photography, and dramatic works. After a basic introduction to copyright and related rights, refreshing knowledge that participants should already have before studying the course, it identifies the three main elements of a well-functioning copyright system: legislation, policy and management of rights. The overriding principle is that whenever it is impracticable or impossible for intellectual property (IP) rights holders to exercise their rights individually, collective management is a feasible solution. The course examines the synergies that exist among stakeholders in the legal, creativity, management, and policy arenas in order to balance the benefits to creators and society. It also discusses the day-to-day work of CMOs and how they are governed. Finally, learners can examine the challenges and opportunities brought about by digital technologies and the Internet through pre-planned questions and answers as well as dynamic discussions among peers and experts.

21. Advanced Course on Collective Management of Copyright and Related Rights for Policy Makers (DL-506)

Description	This advanced course introduces policy-making regarding the collective management of copyright and related rights. It considers the three main elements of a well-functioning copyright system: legislation, enforcement and management of rights. Management of rights is mostly the task of the private sector, but in cases where legislation includes special stipulations on collective management, policymakers have a direct role too. The main objective of the course is to examine different legislative frameworks for collective management and study what role government can play in the collective management of rights. It also raises awareness of how creators, users, legislators and society at large benefit from the system of collective management in music and sound recordings, film and audiovisual, print and publishing, visual arts and photography, and dramatic works. Policymakers have a direct role in legislation and enforcement. Their primary role is to lay down legislative frameworks for copyright and collective management. In some countries, they can also have a supervisory role in relation to collective management.
Content and structure	This course includes two modules and a final exam: <ul style="list-style-type: none"> • Module 1: Introduction to collective management • Module 2: Collective management for policymakers • Final exam
Teaching	Academic support is provided by experienced tutors who are expert practitioners in the field of collective management.

Special group projects will be launched by the Academy and its tutors on topics in which the participants show a high level of interest and engagement.

22. Advanced Course on Software Licensing Including Open Source (DL-511)

Description	This advanced course aims to enhance awareness of the possibilities and implications of proprietary and open-source software, and to create useful sources of information including concrete examples and a bibliography on software licensing, whether proprietary or open source, with a special emphasis on the needs of developing countries.
Content and structure	The course includes four modules and a final exam: <ul style="list-style-type: none"> • Module 1: Intellectual property (IP) regimes for software • Module 2: Software licensing – traditional and open source • Module 3: Benefits and risks of open-source software strategies • Module 4: Public policy options to support wider access to open source software • Final exam
Teaching	Academic support is provided by experienced tutors who are expert practitioners in the field of software licensing.
Online discussions and assignments	Using the Academy's enhanced learning platform, experienced tutors/IP experts discuss landmark cases with participants. Special group projects will be launched by the Academy and its tutors on topics in which the participants show a high level of interest and engagement.
Final exam	The final exam for this course includes a series of multiple-choice questions. Participants have a fixed amount of time in which to complete and submit the exam online.
Certificate	Participants who pass the final exam are awarded an electronic certificate of completion for the course.
Duration	The DL-511 course requires approximately 30 hours of study time over a period of four weeks.
Target audience	This course is open to legal practitioners, managers in copyright offices and staff in collective management organizations, broadcasting organizations or publishing industries and academics and university students with a prior knowledge of IP such as those who have successfully completed course DL-101 General Course on Intellectual Property or course DL-201 Advanced Course on Copyright and Related Rights.

23. Executive Course on Promoting Access to Medical Technologies and Innovation (DL-701)

Description	This executive course aims to provide an overview of the interplay between the distinct policy domains of health, trade and intellectual property. The course describes how they affect access to, and influence innovation in, medical technologies. It draws together the respective areas of expertise of the World Health Organization (WHO), WIPO and the World Trade Organization (WTO). It is based on the joint WHO/WIPO/WTO study <i>Promoting Access to Medical Technologies and Innovation</i> .
Content and structure	The course consists of the following topics and a final exam: <ul style="list-style-type: none"> • Policy context for action on innovation and access • Issues on access from a public health perspective • Health systems-related determinants of access • Issues on innovation and public health with a focus on neglected diseases • The role of intellectual property in innovation and access • Trade-related issues and access to health-related products • Final exam
Teaching	Academic support is provided by experienced tutors who are experts in the field. The Academy also offers a self-paced, non-tutored version of this course which is offered free-of-charge.
Online discussions and assignments	Using the Academy's enhanced learning platform, experienced tutors/IP experts discuss landmark cases with participants. Special group projects will be launched by the Academy and its tutors on topics in which the participants show a high level of interest and engagement.
Final exam	The final exam for this course includes a series of multiple-choice questions. Participants have a fixed amount of time in which to complete and submit the exam online.
Certificate	Participants who pass the final exam are awarded an electronic certificate.
Duration	The course requires approximately 10 hours of study time over a period of four to five weeks.
Target audience	The target audience for this course primarily includes technical professionals such as patent examiners, health policymakers and their assistants, drug procurement specialists, IP specialists and senior students. It is recommended that participants have a basic knowledge of intellectual property and how it relates to health and trade issues at policy level before they study the course.

24. Advanced International Certificate Course on IP Asset Management (Based on IP Panorama and DL-450-IP Management Courses) (AICC)

Description	The objective of this course is to provide an opportunity to participants in courses DL-IP Panorama and DL-450 Advanced Course on Intellectual Property Management who have little means to access intellectual property (IP) education programs, to deepen their knowledge in the specific field of IP management. This course is offered in collaboration with the Korean Intellectual Property Office (KIPO), the Korea Advanced Institute of Science and Technology (KAIST), and the Korea Invention Promotion Association (KIPA).
Content and structure	This course consists of the following three stages: Stage 1: Two online courses: (DL-IP Panorama and DL-450) Stage 2: IP essay test Stage 3: Face-to-face training program The face-to-face training is a four-day program, during which participants will learn about and discuss advanced topics and issues in IP asset management.
Teaching	Academic support for stages 1-3 of the course is provided by experienced tutors and trainers who are experts in the field of IP management.
Online discussions and assignments	Using the Academy's enhanced learning platform and that of KIPA-KIPO, experienced tutors/IP experts discuss landmark cases as well as good practices in IP management.
Final exam	Participants who are the best performers in the IP Panorama course and course DL-450 Advanced Course on Intellectual Property Management (stage 1) and the IP essay test (stage 2) will be invited to apply for the face-to-face program of the course.
Eligibility for face-to-face training	Admission to the face-to-face program is subject to a selection process which includes the assessment of each applicant's motivation and qualifications in addition to their performance during stages 1 and 2 of the course.
Venue and date	The training is expected to take place in Seoul, Republic of Korea, in the second half of 2018. More specific information on registration periods and dates for the face-to-face training will be made available at https://welc.wipo.int and on the KIPA IP Discovery e-learning website: www.ipdiscovery.net
Certificate	Participants who pass the online courses, IP essay test and participate in the face-to-face program are awarded a certificate jointly signed by WIPO, KIPO and KIPA.
Duration	Online participation in stages 1 and 2 including the selection process is expected to take 15 weeks. The duration of the face-to-face course will be four days.
Target audience	The target audience for this course is participants from developing countries who are involved in IP-based business development. Female applicants are highly encouraged.

Language of instruction	The course will be offered in English in 2018.

The financial assistance is expected to cover travel to training venue plus subsistence expenses during the four days of the training.

25. IP-Impact Certificate Course – Certificate on General Knowledge of IP (IPCC) (Based on DL-101 General Course on IP and IP Ignite Tool)

Description	The objective of this new course is to provide robust general intellectual property (IP) knowledge to participants from developing countries who are involved in the value chain of professional activities related to using, selling, producing and/or disseminating IP-intensive products and services in rapidly advancing innovative economic activities. There is a knowledge gap in developing countries due to rapid regional/national economic, social, cultural and technological developments, and this course aims to close that gap. During its pilot launch, the course will target downstream professions such as those dealing with information and communication technologies (ICTs), public health administration, multimedia production and teaching. It is offered in collaboration with the Korean Intellectual Property Office (KIPO), the Korea Advanced Institute of Science and Technology (KAIST) and the Korea Invention Promotion Association (KIPA).
Content and structure	The course consists of the following three stages: Stage 1: One online courses: (DL-101 General Course on IP or IP Ignite); Stage 2: IP essay test; and Stage 3: Face-to-face training program The face-to-face training is a three-day program, during which participants will learn about and discuss selected topics. The topics for discussion, languages and regional coverage will change each year. Participants will be selected from among those who achieve a high level of success in the DL-101 or IP Ignite courses offered by WIPO and KIPA-KIPO respectively.
Teaching	Academic support for stages 1 to 3 of the course is provided by experienced tutors and trainers who are experts in the field of IP management.
Online discussions and assignments	Using the Academy's enhanced learning platform and that of KIPA-KIPO, experienced tutors/IP experts discuss important and relevant good practices in relation to the chosen IP topics.
Final exam	The best performing participants in DL-101 or IP Ignite (stage 1) and the IP essay test (stage 2) will be invited to apply for the face-to-face program of the course.
Eligibility for face-to-face training	Admission to the face-to-face program is subject to a selection process which includes assessment of each applicant's motivation and qualifications in addition to their performance during stages 1 and 2 of the course.
Venue and date	The date is expected to be in the second half of the 2018. More specific information on registration periods and dates for the face-to-face training will be made available at https://welc.wipo.int .
Certificate	Participants who pass the one of the online courses and the IP essay test and participate in the face-to-face program are awarded a certificate jointly signed by WIPO, KIPO and KIPA.
Duration	Online participation in stages 1 and 2 including the selection of participants is expected to take 15 weeks. The duration of the face-to-face course will be three days.
Target audience	The target audience for this course is participants from developing countries who are involved in the value chain of professional activities related to using, selling, producing and/or disseminating IP-intensive products and services. Their daily professional activities may not be focused on IP law as such, but are nonetheless a key gateway for the proper handling of IP-related activities downstream by others.

Language	The course will be offered in English in 2018.
Scholarship and tuition Fee	Financial assistance is provided by the WIPO Academy, the Korean Intellectual Property Office (KIPO) and the Korea Invention Promotion Association (KIPA) to a limited number of applicants. The financial assistance is expected to cover tuition fees during the online learning, travel to the training venue and subsistence expenses during the three days of the training.

26. Intellectual Property for Teachers of the Young (IP4Teachers) (New pilot)

Description	This course is offered in response to the demand for support by WIPO Member States to introduce IP curricula for the young. There is a lack of access to and planning for IP education for teachers of the Young. Teaching IP tends to be left to university level and law schools when in fact kids interface with IP issues at a much younger age every year. The course covers all domains of IP using the DL-101 course and focuses on Copyright, Patents and Trademarks so that teachers could dynamically embed teaching about these domains of IP in their classrooms and curricula. The main tenet of this course is the teacher's role in encouraging creativity and inventiveness with a view to develop the young's entrepreneurial and philanthropic imagination. The second tenet is the teachers' effort to demonstrate and support the young in appreciating early on the effort that goes into bringing creative works and inventions to the public.
Content and structure	This course consists of instructionally-designed modules providing an overview of existing policies, IP learning content, teachers' tools, kids' interactive games and quizzes, and a final teachers' assessment. The audio visually enhanced interactive games are divided into the following topics: Topic 1: Introduction to existing IP teaching challenges Topic 2: General Course on IP (DL-101) with a tutor Topic 3: Three interactive games on the following IP domains: Game 1: Copyright (30 min) Teachers' Tools (180 min) <ul style="list-style-type: none"> • Copyright Case Study • Copyright Lesson Plan • Copyright Student Activities • Copyright Teachers' Notes Game 2: Patents (30 min) Teachers' Tools (180 min) <ul style="list-style-type: none"> • Patent Case Study • Patent Lesson Plan • Patent Student Activities • Patent Teachers' Notes Game 3: Trademarks (30 min) Teachers' Tools (180 min) <ul style="list-style-type: none"> • Trademark Case Study • Trademark Lesson Plan • Trademark Student Activities • Trademark Teachers' Notes Topic 4: Final assessment of self-developed or customized teacher's curricula based on the WIPO Academy tools under Topic 3.
Teaching and final exam	Academic support is provided throughout the course; learners (who should be current teachers) can pose substantive questions to tutors online.
Certificate	An electronic certificate may be generated upon successful completion of Topic 2 (for DL-101) and Topic 4 (for IP4Teachers course).
Duration	The course requires approximately 70 hours of study time over a period of eight weeks.
Target audience	The course is designed primarily for educators and teachers to guide their young target audiences. Persons with responsibility of introducing policies or developing IP teaching guidelines for the young could benefit from this course.

27. Enforcement of Intellectual Property Rights DL-303 (New Pilot)

Description	<p>The objective of this new course is to provide a factual overview of the legal and practical framework of IP enforcement, with particular focus on areas of interest to legal practitioners and IP enforcement authorities.</p> <p>The Course will:</p> <ul style="list-style-type: none"> • provide an overview of the international legal framework surrounding IP enforcement; • set out relevant provisions in multilateral, plurilateral and bilateral treaties dedicated to IP enforcement; • identify the particularities of the topics of IP enforcement and building respect for IP, as well as their attendant challenges; • address topics recurring in WIPO capacity building activities, such as online enforcement, environmentally friendly destruction of IP infringing goods, proceeds of crime and IP and private international law; and • develop example “case studies” illustrating key learning points.

Teaching	Academic support is provided by experienced tutors who are expert practitioners in the area of IP enforcement.
Certificate	An electronic certificate may be generated upon successful completion of the final quiz.
Duration	Each participant can work through the course material at a pace that suits them. It is estimated that the course material can be reviewed in approximately 80 hours.
Target audience	The course is designed for participants who plan to attend further training to fully develop their knowledge on IP enforcement, who are IP enforcement actors; IP practitioners; and students. It is strongly recommended that prospective participants complete the DL-101 General Course on Intellectual Property before studying this course.

28. Introduction to WIPO'S Industrial Property Automation System (IPAS) for Administrators DL-IPAS (New Pilot)

Description	The objective of the course is to provide a good overview of the IPAS system in terms of concepts, technical scope using the appropriate business terminologies associated with the specific procedures, e.g. installing the system and its regular upgrades, configuring the system and applying local technical customization, etc.

General Information

The WIPO Summer Schools provide an opportunity to acquire deeper knowledge of IP, including an understanding of IP as a tool for economic, social, cultural and technological development and the role of WIPO in this regard.

All Summer Schools except the specialized Summer Schools share a common curriculum, format and duration. Participants are exposed to various aspects of IP, including the international nature of IP protection and the interface between IP and other disciplines. The program takes an interdisciplinary, problem-oriented approach and includes lectures, simulation exercises, group discussions on selected IP topics, panel discussions and case studies.
